Focus Group Meetings March 7-9 to Begin Updating Plan Elements

Burnett County is currently undergoing a 10-year update of its Comprehensive Plan. The Burnett County Comprehensive Plan is a guide to the county's physical, social, and economic development, with a 20-year vision for future planning and community decisions.

As part of the plan update process, focus groups have been established by the Comprehensive Planning Committee for the following plan elements: Housing; Transportation; Utilities & Community Facilities; Agricultural, Natural, and Cultural Resources; Economic Development; Intergovernmental Cooperation; and Land Use.

The responsibility of each focus group will be to review and provide recommended revisions for the visioning (goals and objectives), strategy (policies and recommendations), and actions of the previous Comprehensive Plan (Burnett County Year 2030 Comprehensive Plan). Each focus group will provide their recommended revisions to the full Comprehensive Planning Committee for consideration and inclusion in the plan update.

The first round of focus group meetings are scheduled as follows:

March 7: Land Use 9:30 a.m.–11:00 a.m., Housing 12:30 p.m.–2:00 p.m., Transportation 2:30 p.m.–4:00 p.m.

March 8: Agricultural, Natural & Cultural Resources 12:30 p.m.–2:00 p.m., Intergovernmental Cooperation 2:30 p.m.–4:00 p.m.

March 9: Utilities & Community Facilities 12:30 p.m.–2:00 p.m., Economic Development 2:30 p.m.–4:00 p.m.
